## BLANKET LIMITED RELEASE OF COPYRIGHT

## Recitals:

- 1. I am or will become the holder of a copyright or copyrights (collectively "Copyright") with respect to one or more articles previously created or to be created by me and submitted (or to be submitted by me for publication in The Confederate Philatelist (CP) from and after January 1, 2019
- The CONFEDERATE STAMP ALLIANCE, INC. ("CSA") has digitized the print copies of CP and has made digital copies available to its members and/or, at its sole discretion, might make the CP available to other individuals and/or entities as CSA from time-to-time might determine.
- 3. I desire to have the widest possible readership for my Articles and, accordingly, want to have my Articles included among those to be published by CSA in CP print format and in digital format, and made available, as stated above, for reading, copying and/or downloading by members of CSA and by others, as the CSA determines from-time-to-time.
- 4. I have been advised that if I do not grant this BLANKET LIMITED RELEASE OF COPYRIGHT ("BLANKET LIMITED RELEASE") to CSA that my Articles will not be published in CP in either print or digital format.
- 5. I understand that CSA will rely upon receiving this BLANKET LIMITED RELEASE (among other factors and considerations) in making a determination to publish my Articles, but that CSA will not be required to publish my Articles merely because it has received and accepted this BLANKET LIMITED RELEASE. CSA retains all decision rights to publish or not publish the Articles.
- 6. I acknowledge that CSA will rely on this grant of BLANKET LIMITED RELEASE if it publishes my Articles.

## **GRANT OF LIMITED RELEASE:**

- A. In consideration of the foregoing, I authorize CSA to include my Articles among those it publishes in CP, in both print and digital formats, and to make them available as stated in the above Recitals, such availability to be on such terms and conditions as CSA might in its sole discretion from time-to-time determine.
- B. I grant this BLANKET LIMITED RELEASE without payment of any kind required to be made to me by CSA or any other entity or any individual, the consideration for this BLANKET LIMITED RELEASE being CSA's willness to consider publishing the Articles in CP in print and digital formats.
- C. I represent and warrant that (i) I am and will continue to be the sole owner/holder of the Copyright, and (ii) I have not granted or promised and will not grant or promise the rights described in this BLANKET LIMITED RELEASE to any other person or entity. I will hold CSA, its trustees and officers, and CP's Editor harmless from any costs or damages it or they might incur (including attorney's fees and disbursements) by reason of any claim made in contravention of this representation and warranty.
- D. This BLANKET LIMITED RELEASE is granted solely for the purposes stated in the Recitals above, and for no other purpose whatsoever. I retain all other (and do not grant or release) any other rights and benefits to my Copyright not expressly set forth in this BLANKET LIMITED RELEASE.
- E. The duration of this LIMITED RELEASE shall be for the term of my Copyright. I may not revoke this BLANKET LIMITED RELEASE.

By signing this BLANKET LIMITED RELEASE, the undersigned agrees to be bound by its terms and conditions, and agrees that CSA may rely upon its terms and conditions as set forth above.
