ADVERTISING COVERS IN THE CONFEDERACY

Advertising covers offer a fascinating and colorful glimpse into the life and times of antebellum society. Osnaburgs, guano and surreys, products that have long passed from our vocabulary, were prominently advertised 150 years ago. All types of businesses and professionals such as attorneys, colleges, grocers and hotels used envelopes to promote their products and services. The vast majority of AD envelopes were produced in the North, once ties were severed with the South, few printing firms remained to produce them which accounts for their scarcity later in the war.





Above is the census of known Confederate AD covers. Over 1000 businesses are represented many of which have only one known example.







This school was founded by Dr. Marks in 1828, leasing the school to Madame Togno in 1861 upon his retirement. The school lasted the War, succumbing to fire in 1869.

My Dear Sister,

I have only time to write a few lines to tell you we are all well, *but the smallpox is raging in Columbia*, we are afraid to go only for provisions. *The Legislature & the convention moved to Charleston in consequence. There was great rejoicing in town yesterday after the news came that S Carolina had seceded from the Union, the stores were closed from 2 o'clock and the church bells rang for one hour and at night there was a grand illumination, the band came out to Barhamville & serenaded Dr. Marks & the young ladies, the Dr. has written a very good patriotic song - the whole house was illuminated and looked grand. I was over and did not get home till 12 o'clock, Clarence cried so after me that I thought he would go into fits. I have received the money safe, and only wish Pleasant could get it all for me soon. I fear we will have hard times here as well as elsewhere. God grant that we may not have insurrection of the negroes or war with the North.*

All business is stopped in Columbia in consequence of the smallpox. I must close now as Felix is ready to go to town.



J. M. C. Robertson, T. Leslie and A. M. Ragland bought the existing textile/grist mill at Troup Factory in 1846. During the War, they were a large supplier to the Confederate government. Leslie ran the day to day operations while Robertson stayed in Greenville, GA.

The original letter remains with this cover, an interesting excerpt as Leslie writes to Robertson: "We have rec'd one box of cards and have 2 others on the way from Charleston which is the 1st order for clothing for 10 cards complete. They have got thru the blockade; the other order is at Nassau and may yet get through."
