## **Description**

The Aberdeen provisional was prepared by handstamping envelopes in the upper right corner with a prewar postmark in which a large "5" was inserted in place of the date logos. A handstamped "PAID" marking was added to the left of the postmark marking to indicate the postage was paid.

**NOTE**: The inclusion of an item in this census is not a guarantee of authenticity.

### **Early History**

The earliest mention of the 5c Aberdeen provisional is in an 1898 article that illustrates several "locals and handstamps." The illustration is a facsimile of the provisional marking only, but a footnote gives the date of the cover as 20 January. From this we know the cover is CN-003.

Two years later August Dietz identified the Robert S. Nelson as the person who found the cover in a family war-time correspondence. He also illustrated a facsimile of the full cover for the first time.

Charles J. Phillips stated the original finder sold the cover to Ferrary. There is an Aberdeen cover in the third sale of the Ferrary collection described as 5c black on orange envelope, cataloged in Scott (lot 572). While the cover is not illustrated the fact that it was in the Scott catalog is evidence that it was a provisional.
