The Griffin Provisionals

In his book, *Confederate Stamps, Old Letters and History*, Raynor Hubbell relates the story of the Griffin provisionals. He states the Griffin postmaster, Martin A. Bowdoin, ran out of stamps in June 1862 and prepared the 5c Griffin provisional from an old postmark. For a short time, this was used to make postal stationary for customers. Bowdoin also made a 10c value of the same type. Two of the Griffin provisional covers in Hubbell's collection included the original letters which were dated in June 1862, thus proving the 1862 use.

Since the appearance of Hubbell's book in the late 1950s one additional 5c provisional was discovered and a partial cover with the 10c provisional. These new additions extended the period of use from late May 1862 to late July 1862.
