Macon Stampless Provisionals

The 5c stampless provisionals were prepared by replacing the date logos in a prewar postmark with "PAID" and "5" markings and handstamping envelopes with the device. The 10c provisionals were prepared by handstamping envelopes with a "PAID / 10" rate marking.

The "PAID / 10" stampless provisional is only considered a provisional when it is postally unused.

NOTE: The inclusion of an item in this census is not a guarantee of authenticity.


One third of the Macon stampless provisionals have either a penciled "5" or a manuscript paid marking (see example below). The penciled "5" markings (of which there are nine) may be an indication of a clerk writing the rate on the envelope when it was presented for mailing. Later a clerk would apply the appropriate rate marking. This practice was so common in the US stampless period that there was a regulation prohibiting the practice.

The 1847 *Postal Regulations* state:

§ 79. At offices where there is much business, the work of rating and marking should be performed as fast as the letters are received, and not left until the time of closing the mail, when, in the hurry of business, many errors might be committed.

A rate in pencil indicating the rate marking to be applied later is indicative of a stampless use, not a provisional use. However, two thirds of the Macon stampless provisional covers show no such penciled marking. However, some of the penciled markings may have been removed over the years.

This is pointed out so anyone considering purchasing a Macon stampless provisional cover can make an educated decision.


