The Talbotton Provisionals

The E01 provisional was prepared by handstamping envelopes with a Talbotton integral "PAID" marking without rate.

The E02 and E03 markings were prepared by handstamping envelopes with a Talbotton integral "PAID" marking and separating handstamping a "5" or "10" rate marking inside. Because the rates were handstamped separately they have no fixed position in the marking.



Notes

The 5 + 10 Cover



The cover above is listed in the CSA Catalog as a 15c provisional (TAL-GA-E04), but is it? The date of use is July 1861. At this time, the rate was 5c per half ounce. The letter obviously contained legal documents and was overweight. In this case it required triple the normal 5c postage. It is unlikely a 15c provisional had been prepared because it was not a normal rate. To indicate the postage paid the clerk stamped the cover with the integral "PAID" marking that was also used for provisionals. The rate was added separately by carefully handstamping a "5" and "10" inside the marking. Since this would have been done at the time of mailing this is not a provisional cover, it is a stampless cover. This cover is not included in the census. For more information see Ballard in "References."

Problematic Uses

A summary of Talbotton problematic uses is at the end of this section

Provisional with No Value – The provisional marking on the cover below appears to have no value. Was the rate marking so weak it could not be read, or was it erased? The use of the 5c green stamp on the cover is an indication the rate marking may have been extremely weak or non-existent. However, the grid cancel does not tie the stamp to the cover so did the stamp originated on the cover? If the stamp did not originate, the cover may have been a provisional circular. The real answer will probably never be known. This cover is included in the census (E01a, 21Apr1862, CN-007).



The Puzzling Turned Cover – The cover below is a puzzle. The best description of the cover as put together from two auction descriptions and the files of the Civil War Philatelic Authentication Service is as follows. Note the sources do not always agree on the dates and other details so the information given represents a consensus of these details.




The inside use is from Suggsville, Alabama, to Talbotton, Georgia, and bears a 4 December 1863 Suggsville manuscript postmark and matching "Paid 10 cts." The outside use is from Talbotton to Columbus, Georgia, and bears a 14 December 1863 postmark and the Talbotton "PAID 10" provisional marking. What is not explained the postmark at lower left and the handstamped "PAID" and manuscript "10" markings above the address panel. At one time there was also a fraudulent circled "PAID" marking that was removed between November 1973 and September 1986 (see images below).


If the illegible postmark at lower left and the "PAID" and manuscript "10" markings are ignored this would be a normal provisional use. The postmark at lower left is probably that of Americus, Georgia, and the "PAID" marking may also be an Americus marking. Was the letter put in the wrong mailbag at Talbotton and ended up in Americus? If so there should be a missent marking and there would be no reason for the "PAID" and "10" markings. Another explanation is that the letter originally was delivered to the addressee at Columbus. It was then carried to Americus by someone who then reused the cover and sent it back to the addressee at Columbus. In this case why were the Talbotton markings not lined through. We will probably never know the real story behind this cover.

The cover received a good certificate from the Civil War Philatelic Authentication Service (01829). It is included in this census (E03, 14Dec1863, CN-038). In addition to the files of the Civil War Authentication Service, the following auction catalogs were referenced: Richard C. Frajola,14 September 1986 (#29), and Robert A. Siegel. 24 June 2015 (#1104).

The 15c Cover – This cover is an anomaly (see image next page). It is a legal size cover that contained a will. The filing notation is 1863, but the letter was mailed in March 1862, if the "15" notation at upper right is a rate.

There are three possible scenarios. The provisional envelope was taken to the post office out of concern it was overweight. There it was determined it required 15c postage and the "15" notation added at upper right instead of revaluing the provisional. The second is much like the first except the letter was dropped in the post office box. On sorting the mail, the clerk noted the letter was over-weight and marked it with the correct rate – 15. The additional postage was then charged to the account of the legal firm which was probably well known. Finally, there is the possibility the letter was mailed and the 10c provisional accepted as postage. On receipt the "15" was added by the recipient as some sort of docketing. The first two cases also beg the question why wasn't a paid marking added?

This cover received a good certificate from the Civil War Philatelic Authentication Service (04305). It is included in the census (E03x, 24Mar[1862], 027).




"Paid" Covers – Three covers have a manuscript "Paid / 5" or "Paid" marking in what appears to be the same hand as the address. The markings on these covers may indicate the amount of postage a servant who took the letters to the post office was to pay. This was a method used to ensure servants did not steal some of the money. If this were the case with these three covers they would be stampless covers instead of provisionals. Since there is no proof a servant carried them they are included in the census (E02, 6Sep1861, CN-009; E02, 17Sep1861, CN-010; and E03, 16Jun1863, CN-015).

Adversity Covers – Adversity covers were prepared by hand from book or ledger pages, documents, or of from previously used covers. It is difficult to image that such a cover would be taken to post office for application of a provisional marking and taken back home for later use. More likely they were probably used immediately on preparation and thus stampless covers. However, some adversity covers could have been prepared, handstamped with a provisional marking and saved for later use as a provisional. Adversity covers are included in the census.

Folded Letters – Folded letters were made from large sheets of paper folded to letter size. Were the sheets pre-folded as envelopes or were they full sheets when stamped with the provisional marking? Or were the folded letters presented at the post office for payment of postage at time of mailing (stampless covers) Since we don't know the answer, these covers are included in the census.

Charge Box Markings – There are seven letters with charge box markings in one form or another. Provisional covers with charge box markings are suspicious as the notation was usually applied to stampless letters. For information on both sides of this issue see Crown, and Roth and Kimbrough in "References." All covers with charge box markings are included in this census.

"This Package" – The notation at upper center on this cover is unusual and may indicate it was a "stampless use" on a package instead of a provisional use (see image below). This is reinforced by the cover being cut in half and rejoined with a portion of the middle missing. However, part of the address is to a court, so it is assumed the "package" contained legal documents and may have been a letter and not a "package" in the strict sense of the word. This cover is included in the census (E03, 13Aug1862, CN-026).
