10c Montgomery Provisional Markings

The E06, and E07 provisionals were prepared from specially prepared rate markings that included the name of the postmaster, T. Welsh.

The E08 provisional was prepared from a double circle postmark in which the date logos were replaced with a "PAID" and "10" marking.

The various markings were applied to envelopes brought to the post office so they could be used in the future as a prepaid envelope.

The "T. Welsh" provisional markings were applied in red and blue ink. The change from red to blue occurred about 1 October 1861. The earliest recorded blue ink marking is on 1 October 1861 and very few uses of the red ink markings are recorded after this date.

The earlier census of Montgomery provisionals included all values. That census been broken into two censuses: 2c and 5 values, and 10c values. The census numbers have also been reassigned.

NOTE: The inclusion of an item in this census is not a guarantee of authenticity.

Notes

Announcement of the Montgomery Provisionals

The following appeared in the *Montgomery Weekly Post*, dated 12 June 1861, under the page dated 7 June 1861. In the third paragraph of the announcement, it appears postmaster Welsh is setting his own 10c rate even though he specified the 10c rate only applied to covers over 500 miles. Specifically, many towns in Louisiana and almost all towns in Mississippi are less than 500 miles from Montgomery.

Confederate States Postage.—Envelopes properly stamped will be furnished at the post office until Government stamps can be procured.

The postage on all single letters not exceeding 500 miles, will be 5 cents; over 500 miles, 10 cents.

All single letters mailed at this office for Virginia, North Carolina, Arkansas, Texas, Louisiana (except New Orleans), Memphis, Tennessee, North and West Mississippi, will pay 10 cents.

Single letters are such as weigh not exceeding half an ounce, every additional fraction of an ounce will double the postage.

All drop letters will pay 2 cents.

Business men will do well to preserve this list for reference, as all letters must be prepaid in full.

The 10c black provisional (MON-AL-E08)

The six recorded examples of this provisional have historically been improperly described as to their year of use. To some measure this is the result of accepting an enclosure as original to a provisional envelope (CN-146, addressed to D W Boseman Esqr). While the letter may well have a dateline of December 1861 the letter may not be original to the cover. This conclusion is based on the Montgomery postmark which does not have a year date.

The Civil War Philatelic Authentication Service examiner of CN-132 (addressed to Rev Wm A Stickney) pointed out that the earliest Montgomery postmark he had recorded without a year

date was November 1864 (certificate 02169). A separate examination of Montgomery covers revealed no year date in the Montgomery postmark after 1863.

If November 1864 is considered the earliest Montgomery postmarks without a year date were used, then all uses of the 10c black provisional must be between late 1864 and the spring of 1865. Such a late uses also poses the question: were they really provisionals?

One of the 10c black provisionals was probably used as an overpaid drop letter. The cover was then used again from Grenada, Mississippi with a 10c Keatinge and Ball print. Production of the Keatinge & Ball stamps did not commence until the summer of 1864. Therefore, the April Grenada postmark must be from 1865. The front and back of this cover are illustrated below.





Charge Box Markings

A number of Montgomery covers bear a charge box marking (see table next page). Even though postmaster Welsh announced the sale of "envelopes properly stamped" (stampless provisionals) in early June the charge box markings on some covers indicate that some envelopes were stamped at the time of mailing (stampless covers). The endorsement of "post paid" and "paid" may be a clerk's notation that covers received over the counter were paid.






