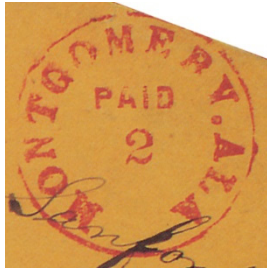


Census of Montgomery, Alabama, 2c and 5c Postmaster's Provisionals

Montgomery 2c and 5c Provisional Markings

The E01, E02 and E03 provisionals were prepared by replacing the date logos in a prewar postmark with a "PAID" and "2" or "5" rate marking.

The E04 and E05 provisionals were prepared from specially prepared rate markings that included the name of the Postmaster, "T. Welsh."

The various markings were applied to envelopes brought to the post office so they could be used in the future as a prepaid envelope.

The "T. Welsh" provisional markings were applied in red and blue ink. The change from red to blue occurred about 1 October 1861. The earliest recorded blue ink marking is on 1 October 1861 and very few uses of the red ink markings are recorded after this date.

The earlier census of Montgomery provisionals included all values. That census has been broken into two censuses: 2c and 5 values, and 10c values. The census numbers have also been reassigned.

NOTE: The inclusion of an item in this census is not a guarantee of authenticity.

Notes

Announcement of the Montgomery Provisionals

The following appeared in the *Montgomery Weekly Post*, dated 12 June 1861, under the page dated 7 June 1861. In the third paragraph of the announcement, it appears Postmaster Welsh is setting his own rates even though he specified the 10c rate only applied to covers over 500 miles. Specifically, many towns in Louisiana and almost all towns in Mississippi are less than 500 miles from Montgomery.

Confederate States Postage.—Envelopes properly stamped will be furnished at the post office until Government stamps can be procured.

The postage on all single letters not exceeding 500 miles, will be 5 cents; over 500 miles, 10 cents.

All single letters mailed at this office for Virginia, North Carolina, Arkansas, Texas, Louisiana (except New Orleans), Memphis, Tennessee, North and West Mississippi, will pay 10 cents.

Single letters are such as weigh not exceeding half an ounce, every additional fraction of an ounce will double the postage.

All drop letters will pay 2 cents.

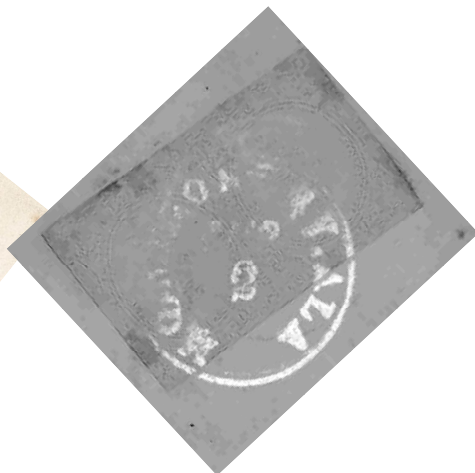
Business men will do well to preserve this list for reference, as all letters must be pre-paid in full.

2c Provisional Marking Used as Postmark

The pair of 5c green stamps (illustrated below) was canceled by a strike of the Montgomery 2c provisional marking in blue and a faint strike of the town postmark in black.

The left image below is of the Montgomery 2c provisional marking. The center image is the pair of stamps canceled by the two markings. The right image is a filtered image courtesy of Postmark Reveal in which the provisional marking is much clearer.



The full cover showing the cover was carried by the Southern Express. Blue Montgomery Southern Express marking UC dated 23 Nov.

It appears the provisional marking was struck over the postmark. In the image below the second "A" of "ALA" in the provisional marking appears to overlay the faint rim of the Montgomery postmark. Since the provisional marking is in blue and the express marking is in same shade of blue it begs the question where and when was the provisional marking applied.

5c Adhesive Provisional

The first record of the Montgomery adhesive provisional (illustrated below) was in the fourth sale of the Ferrary collection (14 June 1922, lot 49). There was no illustration and the short description read: Montgomery, an envelope with a non-cataloged provisional stamp and a 5c green Confederate stamp. The cover passed through several famous collections before it was submitted to an authentication service and received a good certificate (PF-585855). In June 2022 it was sold as part of the Erivan collection (H R Harmer, sale 3060, 24 June 2022).

There is also a note that the cover has the backstamp of Warren H. Coulson.

The provenance is useful as it gives a history of the ownership of a cover. However, it is not a guarantee of authenticity although it is often considered as such. This is because one would not expect the famous collectors who owned a cover to purchase something they did not feel was genuine. Apparently, the cover attracted no real interest when sold in the Ferrary sale as it was not mentioned in Fred Melville's review of the Confederate rarities in the Ferrary sale (see Melville in "References").

A look at the cover shows the provisional is a cut square on which a Montgomery “PAID” marking was applied. This marking is the same as the prewar “3 PAID” marking illustrated below, but with the “3” removed. In red pencil or crayon at the center of the marking is the value “5” and below and slightly to the right the letters “T W[elsh].” It is assumed the full word is “Welsh” but it is difficult to make out all the letters. Thomas Welsh was the name of the Montgomery postmaster.

The provisional stamp is affixed just over the fold line of the upper flap. When the envelope was sealed it created a crease across the top of the stamp. In effect the stamp is “tied” by the fold line crease.

A 5c green general issue was placed neatly over the provisional almost completely hiding it (see illustration below). The stamp was cancelled with the Montgomery postmark dated 5 March 1862 but not a trace of the postmark touches the provisional.

These characteristics give the cover authenticity but other aspects of the provisional are questionable.

The principal concerns are the value and name on the provisional. The descriptions of the cover in the Caspary, Meroni, and Erivan sales state the provisional has the signature of Postmaster Welsh. The only legible letters of the postmaster’s name are the “T” and “W.” The filtered false color image on the next page, obtained by using Postmark Reveal, clearly shows the value and name. Neither the “T” or the “W” match the signature samples of Postmaster Welsh taken from correspondence in January and July 1861. Instead of being written in cursive the name is printed in block letters.

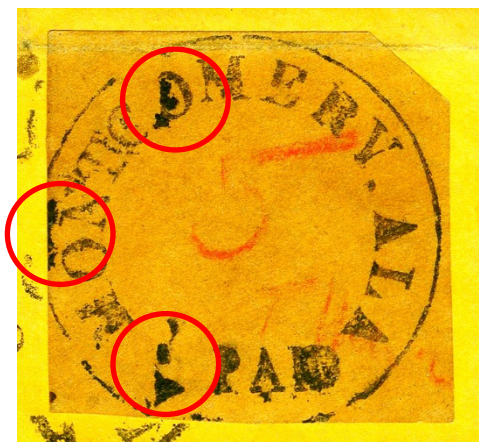

The use of red crayon or pencil for the markings is unusual. No other recorded Confederate provisional has the value in pencil or crayon. They are always in ink (handwritten or handstamped). The same holds true for the name although in most cases the postmaster signed his initials as a control, not his full name. These markings are always in ink or handstamped as a security measure so that the unscrupulous cannot alter the value.

Why was the value in crayon or pencil? Montgomery was the capital of Alabama and although there is no record of a "5" marking used in the Confederate period there was certainly a "5" marking left over from the preceding US administration. If no left over marking was available Postmaster Welsh could have easily obtained one locally.

The Montgomery town postmark used to prepare the provisional is a prewar marking in which the "3" was filed down or cut out (see illustration on previous page). After such effort you would expect the marking to be put in general use, but there are no recorded Confederate covers bearing the altered marking.

Finally, there are the mysterious spots of black ink at the top, bottom and left side of the provisional (see image opposite and false color image above). Close examination reveals that the three spots are actually of a darker ink than the rest of the marking. It is possible the bottom spot was the result of high spots where the "3" was filed down or removed. However, there is no simple explanation for the spots at the top and left center.



Charge Box Markings

A number of Montgomery covers bear a charge box marking (see table below). Even though Postmaster Welsh announced the sale of “envelopes properly stamped” (stampless provisionals) in early June the charge box markings on some covers indicate that some envelopes were stamped at the time of mailing (stampless covers). The endorsement of “post paid” and “paid” may be a clerk’s notation that covers received over the counter were paid with a rate marking to be added later.
