Description



"PD 2 CTS" Marking

The "PD 2 CTS / N. O. P. O." marking is one of three of the same design. The other two are the 5c and 10c values.

The "PD 2 CTS" marking appears to have no period after the final "O." At least none of the seven copies in this census show any evidence of a period.

This marking was previously listed as a provisional. After studying the folded letter (CN-02) and the cover discussed in the "Notes" (F01) it was decided the marking should be listed as a stampless cover.

Census numbers (CN) for this census have a prefix "F."

NOTE: Every effort is made to ensure the accuracy of the census, but the inclusion of an item is not a guarantee of authenticity.

Notes

The Mystery Date

Most descriptions of the cover below do not give a definitive date for the postmark. In this census the date is listed as 22 Jun 1861. This makes it the earliest dated use of the marking as all others are in January 1862. Some may not agree but the June date is certainly possible. There are two examples of the "PD 2 CTS" marking cancelling the 2c blue provisional (A01) and the similar "PD 5 CTS" marking is known in red on a 5c brown provisional (A03). The red ink is known only from early June to mid-July 1861.

The corner card (Galveston, Texas) and the blue manuscript "2" lend some credence to the June 1861 date assuming the following scenario. The cover was placed in the care of a captain or passenger on board a steamer at Galveston bound for New Orleans. In June 1861 the Federal blockade was still being implemented and mail to and from southeast Texas was carried by steamer between New Orleans and Galveston. On arrival in New Orleans the captain or passenger took the letter to the New Orleans post office. There either the captain paid 2c for a drop letter ("PD 2 CTS" marking) and the letter was also marked with the blue "2" to indicate payment due the captain for carriage of the letter. Or if the passenger presented the letter he would have paid the 2c drop rate and cover marked with the "PD 2 CTS" marking. In this case the manuscript "2" may indicate the letter was accepted by a clerk but not marked paid or postmarked until later.


