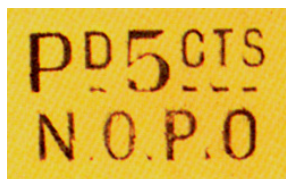


Census of the New Orleans “PD 5 CTS” Marking Used on Covers

Description



“PD 5 CTS” Marking



“J. L. RIDDELL, P. M.” Marking

Little is known about the “PD 5 CTS” marking and its two companion markings: “PD 2 CTS” and “PD 10 CTS.” The 5c and 10c values are considered stampless provisionals while the 2c value is considered a stampless marking.

The “PD 5 CTS” marking was used both as a provisional marking and to cancel adhesive provisionals. Both uses are included in this census.

This census is presented in chronological order (by postmark date) regardless of the postage or marking type. Mini Censuses are presented both chronologically and by order by postage type.

Census numbers (CN) for this census have a prefix “D.”

NOTE: Every effort is made to ensure the accuracy of the census, but the inclusion of an item is not a guarantee of authenticity.

Notes

The “PD 5 CTS” Marking

The “PD 5 CTS” marking was used both as a provisional marking and to cancel New Orleans provisionals. It includes all the 5c New Orleans stampless provisionals, and all outbound covers with the New Orleans double circle postmark and bearing a New Orleans adhesive provisional.

The RIDDELL Marking

The purpose of the “J. L. RIDDELL, P. M.” marking is unknown. Originally Postmaster Riddell may have procured it for official purposes such as signing post bills. However, there are no known artifacts that show any personal or official use of the marking by Riddell. Instead, all uses of the marking occur on covers that either bear the “PD 5 CTS” marking as a provisional marking or to cancel adhesive provisionals. It is often considered a control when on the “PD 5 CTS” provisional covers.

Outliers

There are two covers on which the “PD 5 CTS” marking is used to cancel an adhesive provisional but there is no “RIDDELL” marking. The first example is dated 21 July 1861 two weeks before the first recorded use of the “RIDDELL” marking on 5 August (CN-D13). The second example is dated 12 August 1861 (CN-D14), a week after the first recorded use of the “RIDDELL” marking (CN-D14).

There is one example of the marking used neither to cancel an adhesive provisional or as a provisional (19Nov1861, CN-D37).
