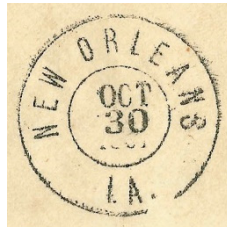


Census of New Orleans Double Circle Postmarks on Inbound Mail by Date

Description



New Orleans Double Circle Postmark

This is a census of inbound New Orleans covers canceled by the town's double circle postmark. Inbound mail is defined as mail with a New Orleans address. As a general rule covers inbound to New Orleans with that town's double circle postmark are considered to be river mail - mail transported by a riverboat.

It is not easy to identify many covers with the double circle postmark as river mail because they lack river boat docketing or markings, and some have 5c New Orleans provisionals or a general issue canceled by the double circle New Orleans postmark. The latter would normally be considered overpaid drop letters. There are at least two explanations for this.

Businesses and individuals upriver from New Orleans might have a supply of New Orleans provisionals or general issues for use on mail to that city. Such letters would be placed aboard riverboats as they passed on their way to New Orleans. Or the purser on a riverboat may have kept a supply of New Orleans provisionals or general issues to accommodate passengers who wished to mail a letter on their trip to New Orleans. In all cases letters picked up enroute by a riverboat were considered "loose mail" and were to be turned in to the post office at New Orleans on arrival. For each letter turned in the captain was entitled to receive one cent if a contract vessel, or two cents if a non-contract vessel.

The common feature of all such mail is the New Orleans double circle postmark. For this reason, the New Orleans double circle postmark has come to signify river mail.

As noted above it is not always easy to definitively identify an inbound cover to New Orleans with a double circle postmark as river mail. An examination of the covers in this census revealed one cover that was probably not river mail (see "Notes).

This census is three different censuses. There are mini censuses by date and type of postage and a full census by date.

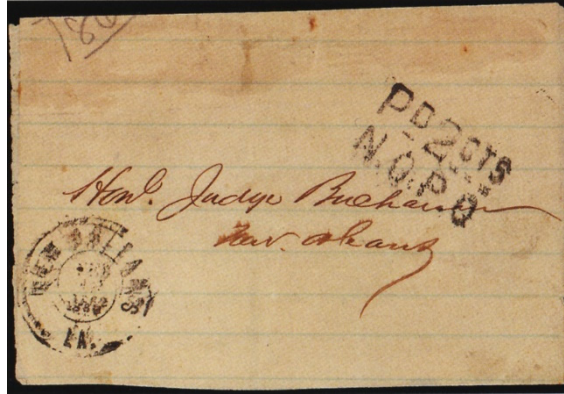

River Mail?

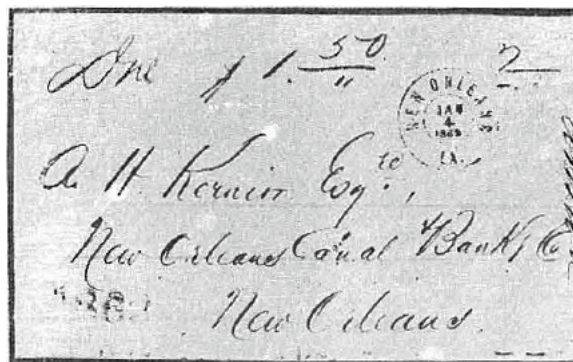

The cover above was mailed as a drop letter in February 1862. Although it may have come down river on a steamboat it would have been carried outside the mail by an individual. If it had entered the mail upriver the correct postage would be five cents not the two cents on this cover. On arrival in New Orleans the individual carrying the letter went to the post office and mailed it as a drop letter. This cover is included in the census (CN-055).

Blockade Run Mail?

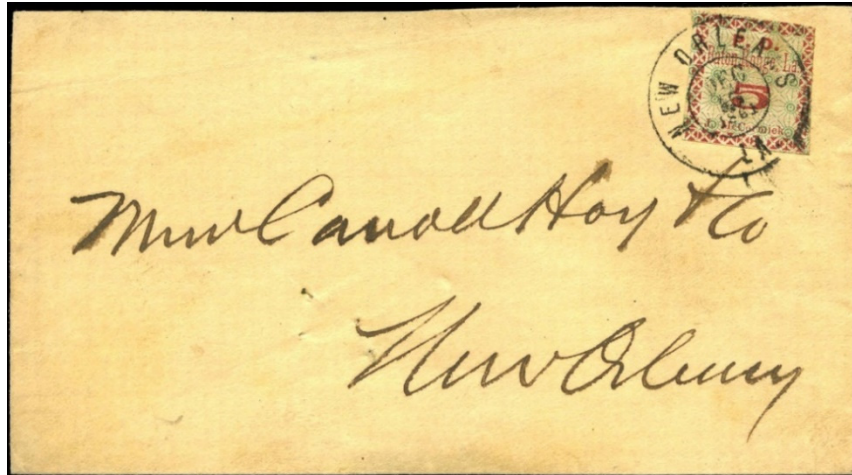
The cover below has been called an incoming blockade cover to New Orleans. The unusual "Due \$1.50" is a special rate Postmaster Riddell put on incoming blockade mail. The manuscript "2" may be the two cents due the ship captain if it were a Confederate vessel. 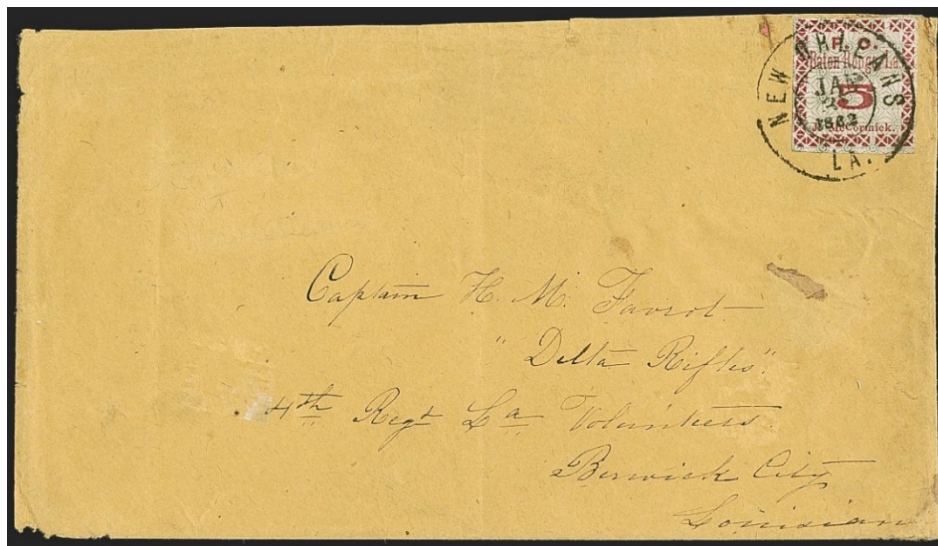
Incoming cover postmarked 4 January 1862

Unusual Uses

The postmaster at Baton Rouge apparently had an arrangement with the New Orleans postmaster whereby his stamps were recognized for postage in that city. The two covers below illustrate such use.



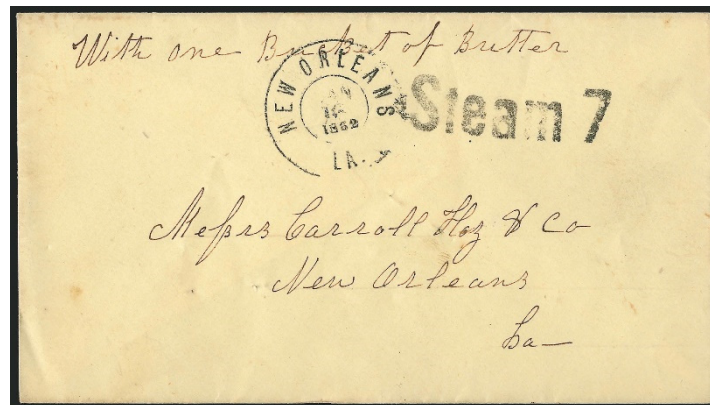

Steam 7 Marking

The Steam 7 marking is somewhat of a mystery. It is found on unpaid letters that entered the mail at New Orleans. The rate of postage for unpaid letters that picked up enroute by a contract or non-contract vessel for delivery at New Orleans was six cents. It is assumed the New Orleans postmaster charged seven cents to recoup the one cent that the post office was obligated to pay the vessel captain. However, there was nothing in the postal regulations that said the one cent fee could be charged to the recipient of the letter.
