



The Columbia Provisionals

The E01 provisional was prepared by handstamping envelopes with a wood cut of a rated oval design on envelopes of various types. Envelopes with this marking have no control marking.

All other types were prepared by handstamping envelopes with a variety of "PAID," "5," and "10" markings. These envelopes have either a round or oval control on front or back.

NOTE: Every effort is made to ensure the accuracy of the census, but the inclusion of an item is not a guarantee of authenticity.

WARNING: Stampless cover used the same “PAID,” “5,” and “10” markings. The only difference between a stampless marking and provisional marking is a control on the front or back. This does not apply to the E01 markings which had no accompanying control.


Not Provisionals

The CSA Catalog lists the marking illustrated below which has an oval control on the reverse as COL-SC-E10.



It also lists two subtypes: COL-SC-E10a (without a control) and COL-SC-E10b (without a control and mailed from another town). These two subtypes should be delisted as they are stampless markings with no control. The control is a necessary feature for all provisionals except E01 and its subtypes.

The cover at above left is considered the earliest use of the E01 provisional. This use is more than two months before the next recorded use. The cover at above right is considered the latest recorded use of the E01 provisional. It is more than six months after the next latest use. It has the original enclosure which according to the auction description is the subject of docketing on the back flap and confirms the 1862 date (RAS Sale 810, Lot 1865).

Both covers are included in the census.

A Few Words on the Columbia Provisionals

When clerks prepared the provisionals they primarily used the handstamp with the oval design (E01). Many times, they also applied a "PAID" marking (E01a) and in a few cases they related the marking to "10" (E01b and E01c). In all these cases no control was used.

All other provisionals were prepared by applying various combinations of rate, paid, and control markings. There is no discernable pattern to their use. It was as if the clerks grabbed whatever was close at hand and used those markings. This can be seen in the chart below that shows the earliest and latest recorded dates of use.
