The 2-cent blue New Orleans provisional

All the New Orleans adhesive provisionals were engraved on wood and reproduced as stereotypes or electrotypes. From these plates of 40 subjects were prepared.

The 2-cent blue provisional was the first of the two New Orleans 2-cent provisionals placed on sale. They are recorded on covers postmarked from early July 1861 to late March 1862.
