The Lenoir Provisionals

The adhesive provisional was engraved on wood by the postmaster's son, George Harper. The wood cut die was then used to handstamp sheets of white paper with orange horizontal and vertical lines. Individual stamps were cut from the sheet. The same wood cut die was also used to handstamp envelopes for use as postal stationery.

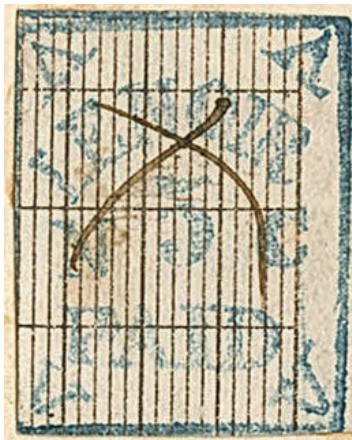
Based on dates of use the first Lenoir provisional was the circular device E02. It was prepared by removing the date logos from a town postmark and inserting "PAID / 5." The device was then struck on envelopes. No control was applied.

The adhesive provisionals exist on three types of paper as illustrated below:

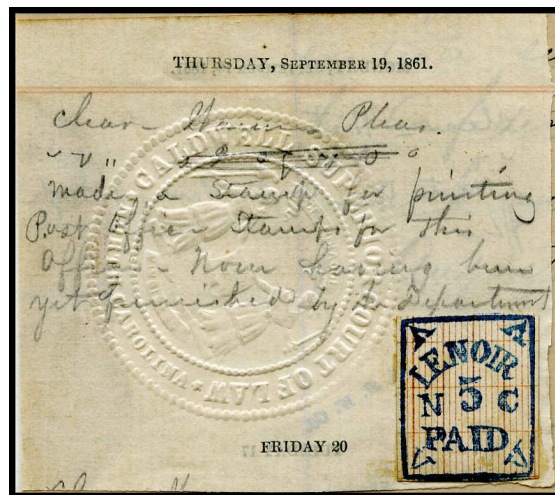

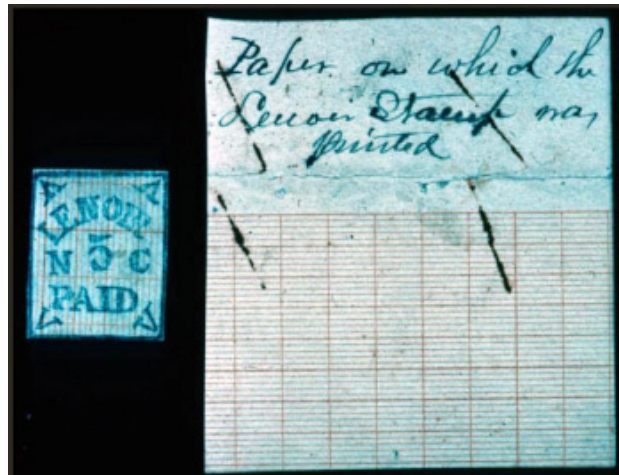
Attached to Diary Page

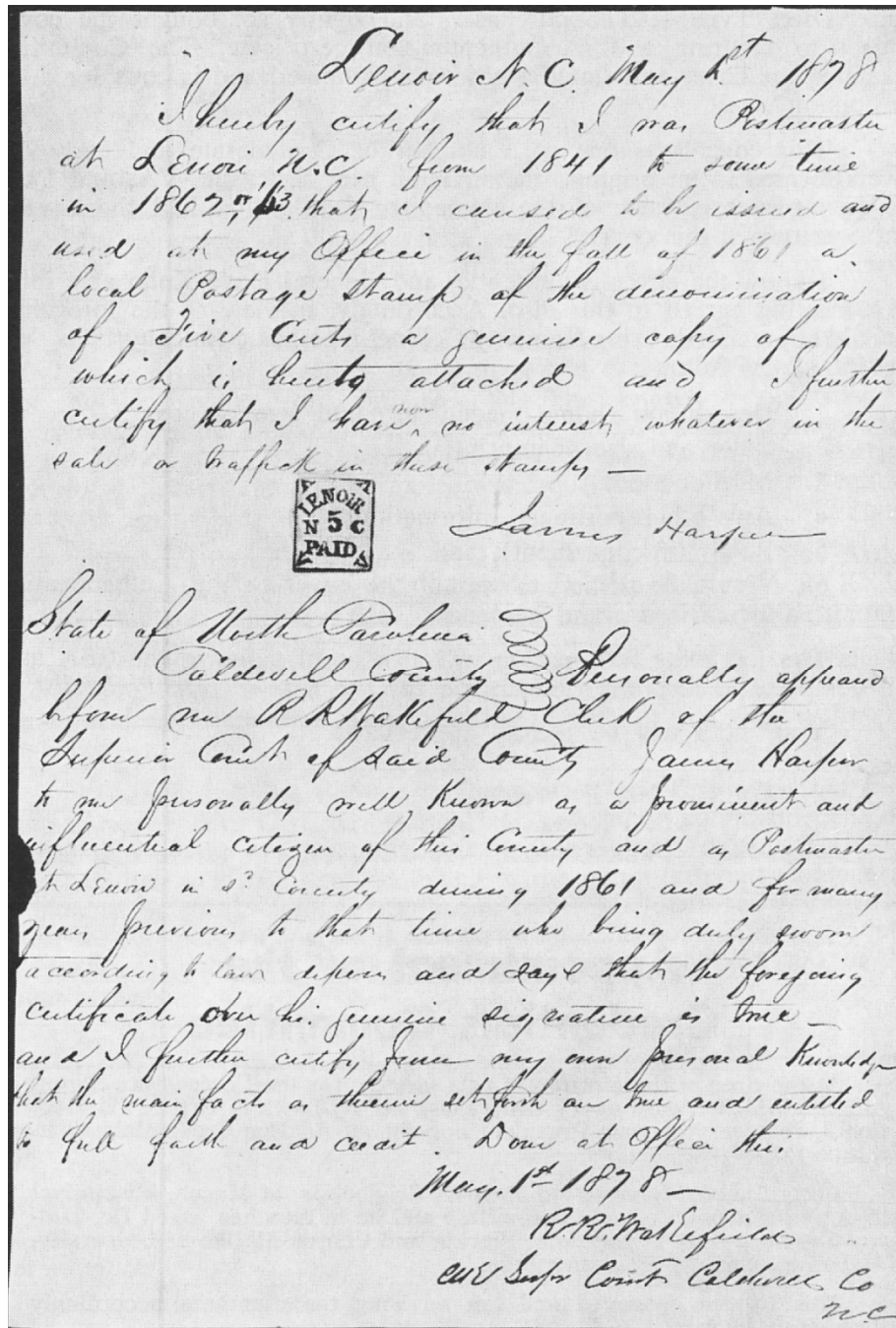
Sample of Paper Used to Print the Lenoir Provisional

Impression of Provisional Made on Fly Leaf of Account Book

Proof impression of the Lenoir adhesive provisional made on the fly leaf of an account book. Signed and notarized by G. W. Harper, the postmaster's son, on 20 May 1911 (CN-012). Although described as a proof impression, this is unlikely. It was merely an impression made from the original die. Unique Provisional Proof

A proof impression of the five-cent Lenoir postmaster's provisional was made on the fly leaf of an old account book (as explained by the signed and notarized statement shown below which was executed by the town's former postmaster, G.W. Harper, on May 20, 1911) used in the Lenoir post office in the summer of 1861. Perhaps the rarest of all Confederate postmaster's provisional proofs.

This impression was made on the fly leaf of an old account book used in the Post Office at Lenoir, N. C. from the original die of the Lenoir, N. C. 5 cent stamp engraved by myself in the summer of 1861 and is one of two such impressions now in existence so far as I know. My father was Postmaster at the time and I kept the Post office for him.

Fakes

Most fakes of the Lenoir adhesive provisional are poor. However, there is one modern facsimile that is dangerous. It is a facsimile of an unused provisional (CN-023). Both are illustrated below. Close examination shows the facsimile is a copy of the authentic stamp that includes the slight stain below the "ID" of "PAID."
