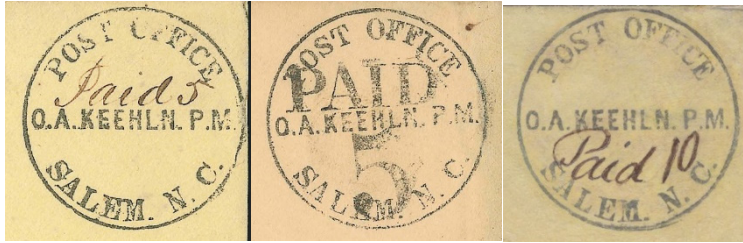

The Salem Provisionals

The Salem provisionals were prepared by striking envelopes with a brass device that included the postmaster's name. The rate was then either written in pen or handstamped. All markings were carefully applied, mostly in the upper right corner. For some reason, the only markings applied at upper left are those covers with the added handstamped "Paid 5" (E02) and those used under a general issue (E01a).

The listing for the provisional marking used under a postally used general issue is incorrectly listed in the CSA Catalog. The underlying provisional marking is SAL-NC-E01, not SAL-NC-E03. This information was confirmed by the owner of the two covers. These covers are correctly listed in this census.

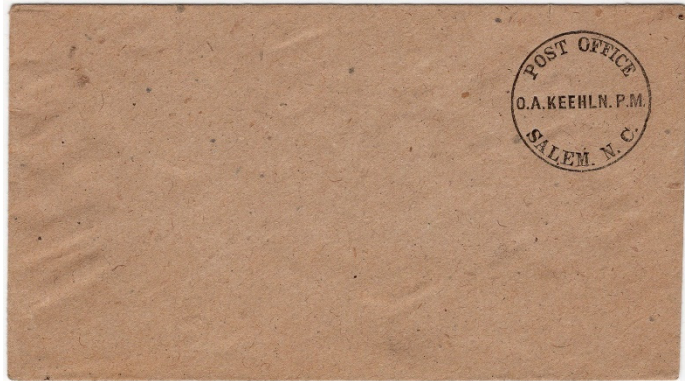

Fakes and Reprints

The die used to make the Salem provisionals survived the war and was later used by his son to make “reprints.” These “reprints” were on a straw or oatmeal type paper. When the rate was included it was not done in the same careful hand as the authentic. Others were handstamped with a special manuscript “Paid 5” die. Examples are illustrated below

Two examples of the provisional reprint with the rate added by the fake "Paid 5" die. Some characteristics of the fake die are: The flat bottom of the loop at the bottom of the letter "P." The flag of the numeral "5" is low and in a small arc rather than a straight line.

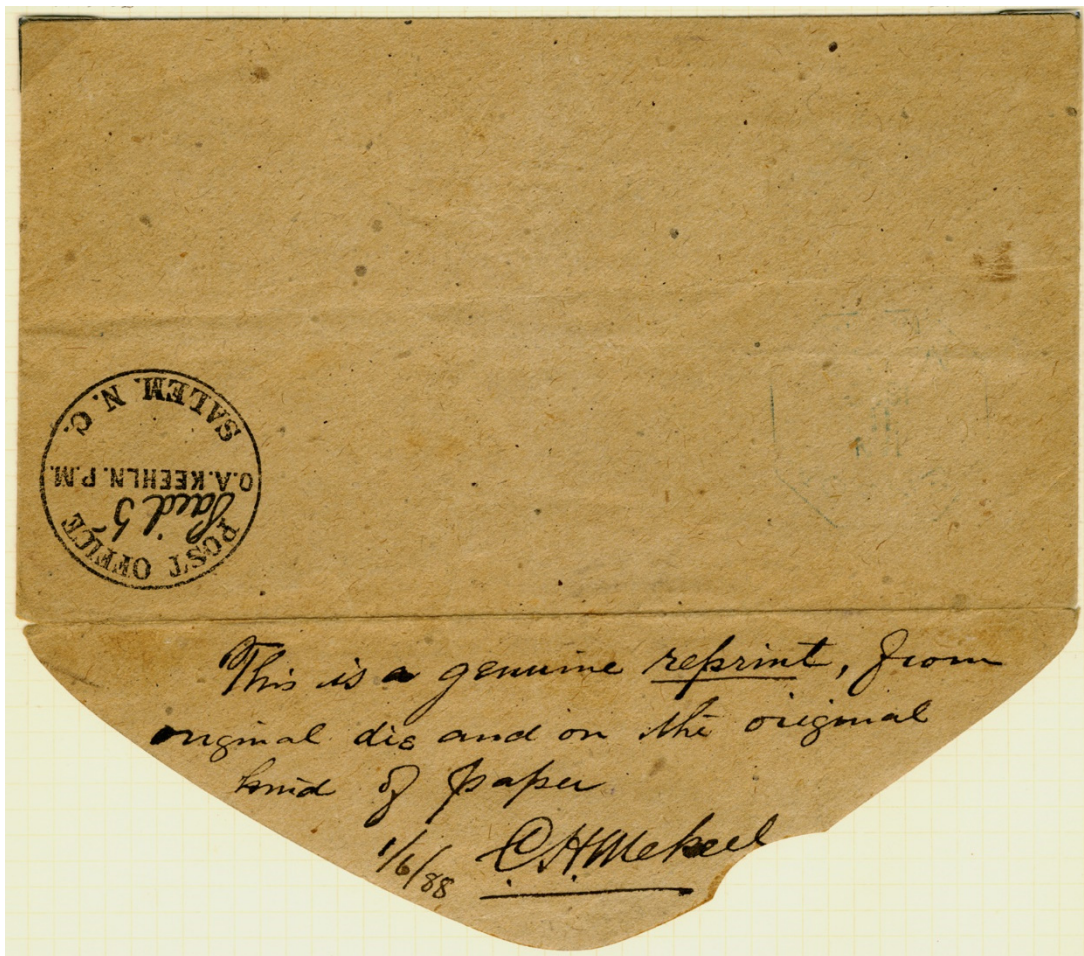
Pre-War Use of the Salem Provisional Marking

In late 1959 an estate that included the die of the Salem provisional went up for sale. Ten years later Benjamin Wishnietsky had an article that featured the Salem provisional marking on the backflap of two pre-war envelopes. Because the die of the provisional marking was available it is very possible these covers were prepared post war. See Spelman and Wishnietsky in "References."



From the Freeland Collection

The reprint illustrated below is captioned in the Freeland Collection as being a Mekeel Reprint. However, it is not known if Meekel made reprints of this provisional or not. This could be a reprint prepared by postmaster Keehln' son. The year date of the notation on the flap is the same year Keehln's son began offering the reprints. See Rothfuchs in "References."
