The LaGrange Provisionals

The LaGrange provisionals were prepared by removing the date logos from an old office postmark and replacing them with “PAID / 5”, “PAID / 10” and “10 / PAID” markings.

Caution: Seven of the listed LaGrange covers have charge box markings. One of these is on a folded letter which received a “genuine use of the provisional marking as a handstamped paid” certificate (04984) from the Civil War Philatelic Authentication Service (E01, 27May1862, CN-001).

NOTE: The inclusion of an item in this census is not a guarantee of authenticity.
