Description



The Memphis 5c Entire Provisionals

The Memphis 5c postal stationery provisional envelopes were printed from the same electrotpe used to print the 5c adhesive. It was printed in the upper right corner of envelopes of various colors. The printing was done in the offices of the *Memphis Avalanche*, owned by M. C. Galloway, who was also the postmaster at Memphis.

All Memphis postmarks are considered to have year dates of “1861” or “1862” even if the year date does not show in the postmark.

NOTE: The inclusion of an item in this census is not a guarantee of authenticity.

Notes

Announcement of Stamped Envelopes

The last part of the announcement below is important in understanding why the Memphis 5c entire is found on so many different color envelopes. It also explains why the CSA Catalog does not list the entires on different color envelopes. If citizens could bring their own envelopes to be printed, the postmaster had no control on this aspect of their production. Thus, there is no reason to list them on different color envelopes.

The Postmaster-General has not yet been able to procure stamps to supply the Confederate States. This will occasion some inconvenience to business men. We learn that it will be impossible to procure stamps for the Confederate States for some time. To obviate, as far as possible, the inconvenience thus occasioned, the Postmaster of Memphis is making arrangements to print a large number of pre-paid or stamped envelopes, which will be ready for the accommodation of the public by the 1st of July. Fakes

There are many fakes of the 5c Memphis adhesive and entire. The authentic adhesive and entire were both printed from the same electrotype, so the differences noted below apply to both. The fakes are easy to spot. Look for a thick solid line of color between the flag of the “5” and the top outside border of the counter on the “5” (below right). This line is not found on the fakes (below left), though some do have a partial line or solid dot.

Another way to tell a fake is to look at the two diamonds below the “5.” On the genuine the two diamonds almost touch or touch the bottom of the “5.” On the fakes the tops of the diamonds are cut off, greatly distorted, or absent.
