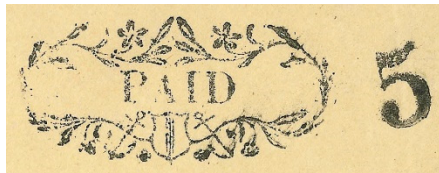

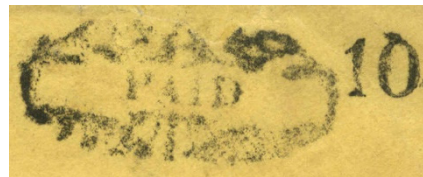

Galveston Provisionals

The Galveston provisionals were prepared by using a variety of different handstamps. Two that stand out are those with "PAID" in a fancy ornamental border and the "5" or "10" rate struck separately.

Two other 5c markings were made by removing the date logos from postmarks and either replacing them with "5 / PAID" or handstamping over the marking with a "5" and striking a "PAID" marking to the side.

The markings used for the other 10c and 20c provisionals were old markings that were used for circular mail. In the center of these markings the rate "10" or "20" was struck. One variety has a "3" in front of "PAID."

There are several covers with postmarks that have “1860” year dates. This was an error on the part of the postmaster or a clerk. Most such covers were used in “1861.”

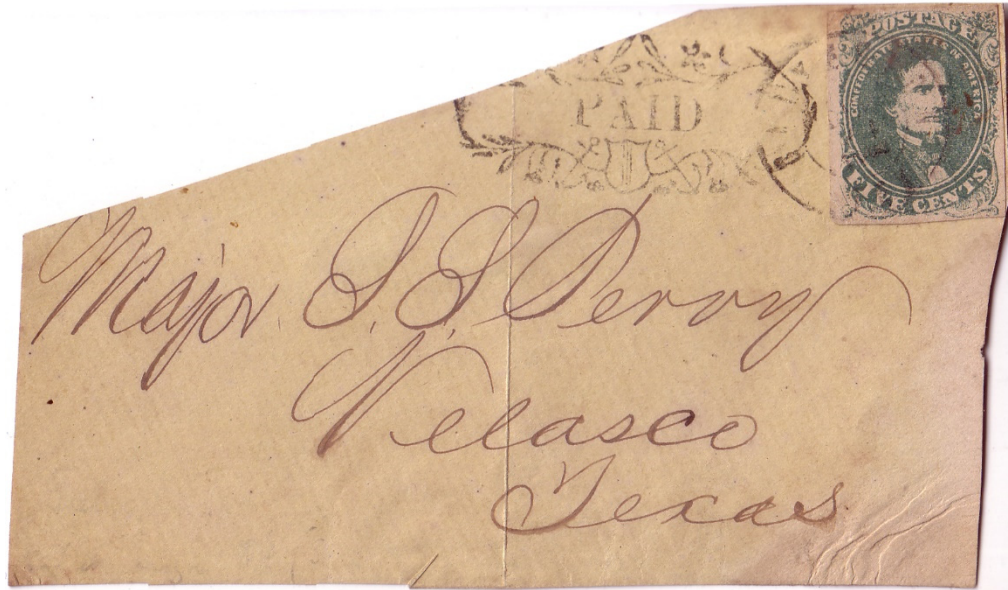

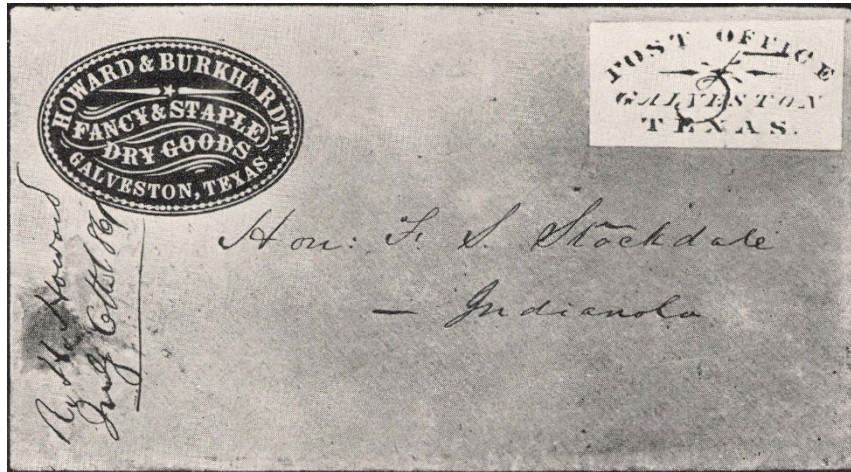
Notes

Provisional or Unusual Use of Provisional Marking as a Cancelling Device?



It is not known if there is a rate marking under the stamp on the cover above. If there is the cover would be as a general issue used of a provisional marking. If not, then perhaps the fancy part of provisional marking was used as a canceling device. The clerk, probably without looking, grabbed what he thought was the postmark and struck the cover with the fancy part of the provisional marking. Realizing his mistake, he then cancelled the stamp with the Galveston postmark. This cover is not included in the census.

A Fake Adhesive



This cover has been around at least since 1926. The adhesive is considered a fake. Reprinted from the *Southern Philatelist*, August 1926, page 210.

August Dietz's *Postal Service of the Confederate States of America*, page 45. gives a few details about the stamp. It was printed on white paper with blue lining. It was found by Fred Green of Texas.
