The Darlington C. H. Provisional

The Darlington provisionals were prepared by using the office "PAID" and "3" markings to stamp envelopes.

Provisional E0x was used in the relatively brief period before 1 June 1861, when Darlington was short of stamps. It is considered a provisional only when a Confederate stamp is used over the handstamped markings (see Notes).

**NOTE**: The inclusion of an item in this census is not a guarantee of authenticity.

#### The PAID 3 Marking

The Darlington 3c provisional was prepared like the US 3c stampless cover below. In the case of the Darlington provisional the prepaid envelope was never used during the brief period US postage was valid before 1 June 1861,

There is no way to determine if the cover below was prepared in advance of use. It is very doubtful because the month of use is August. US postmasters in the South prepared provisionals only between January and the end of May 1861.
