
Census of Newberry C. H., South Carolina, Stampless Markings

Description



The different markings are identified by the *Confederate States of American* (CSA) *Catalog and Handbook* Stampless Type. The letters "X, Y, and Z," are used to designate added items not in the CSA Catalog. The absence of a CSA Catalog Type in the illustrations above indicates that item is not included in the census.

Items are presented in the census in the order of the illustrations above.

This census is based on images of covers. Only covers for which an image was obtained are listed in the census. For this reason, this census may be far from complete.

NOTE: Every effort is made to ensure the accuracy of the census, but the inclusion of an item is not a guarantee of authenticity.

Notes

Types A and X

The 2012 CSA Catalog lists the "PAID" marking (Type A) with a manuscript "10" and a pencil "10." Since the catalog was published the cover with the pencil "10" was determined to be the cover illustrated below. The pencil markings are probably those of the letter writer and do not represent a rate applied at the post office. This cover is listed as a "PAID" marking with no rate in this census (Type X).
