# Census of Mobile, Alabama, Stampless Covers

Description

The different markings are identified by the 2012 *Confederate States of American* (CSA) *Catalog and Handbook* Stampless Type. The letters "X, Y, and Z," are used to designate added items not in the CSA Catalog. The absence of a CSA Catalog Type in the illustrations above indicates that item is not included in the census.

Items are presented in the census in the order of the illustrations above.

This census is based on images of covers. Only covers for which an image was obtained are listed in the census. For this reason, this census may be far from complete.

**NOTE**: The inclusion of an item in this census is not a guarantee of authenticity.

**Dates** – Most dates are taken from the postmark. In those cases where there is no Mobile postmark, or the postmark is illegible a derived date is in brackets. Derived dates are based on the period of use of a rate, the date in a non-Mobile postmark, or research into the location of the addressee.

**Two Covers in the Census Twice –** Two covers are listed twice in the census because they have two stampless markings on them.

CN-064 A & B – Types E and I, no date.

## **Provisionals?**

Almost 100 years ago it was suggested that the three handstamped markings (Types A, B, and C) were prepared as provisionals (see Pratt in "References"). The article presented good arguments for the markings to be elevated to provisional status. However, one key feature not addressed was control markings. None of the recorded uses of the markings have a control marking. Covers with a rate marking need a control marking to distinguish a stampless use from a provisional use. Without a control marking or some other unique feature the uses are stampless covers.

These three markings are unique in that they were only used from 1 June 1861 to 10 July 1861. They were immediately followed by the Mobile adhesive provisionals. The earliest recorded use of the 5c Mobile provisional is 14 August 1861 just four days after the last recorded use of one of the three stampless markings. It is possible that this four-day gap may be further reduced in the future.

It is strange that there is no overlap in the period of use of the stampless markings and provisionals. Further the stampless markings were available for use on 1 June. There is no record of these markings being used before 1 June 1861, so they were prepared specifically to meet the Confederate postage rates.

During the period in which the Pratt article was written there were some markings that gained provisional status based solely on their fancy quality. These Mobile markings probably fall in that category, but they have never been accepted as provisionals.


## The "2" Covers

None of the covers bearing the "2" marking (Type D) has an accompanying Paid or Due marking. Postal laws required the prepayment of postage on all letters (except soldier's letters after 29 July 1861). However, Mobile did not mark any letters with a numeric marking "due," even though they should have been. Lacking any other information, we must assume covers bearing the "2" marking were not paid in advance.

### **Rate Reaffirmed or Receiving Mark?**

Some auction catalogs have described the 5 (Type E) and 10 (Type F) markings as receiving marks. The reason for this may be the fact that when the 5 and markings were used there is no indication whether the rate is paid or due. In most cases the 5 and 10 Mobile markings were used on soldier's letter, unpaid, or underpaid letters to indicate the postage due. In other cases, it is apparent the due rates were being reaffirmed, perhaps to alert clerks to a letter with postage due. For more on reaffirmation see Francis J. 


