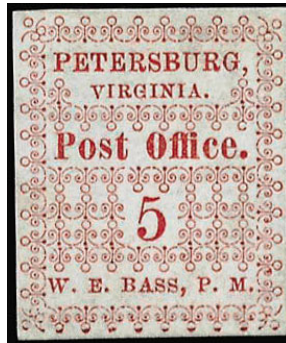


Census of Petersburg, Virginia Postmaster's Provisionals

Description



The Petersburg Provisional

The Petersburg provisional was typeset and laid out in a printing form of ten subjects arranged in two rows of five settings each. It was printed on thick white wove paper.

It is unusual for a town of Petersburg's size not to have a number of provisional patriotic covers. This census records only one dated 14 December 1861 (CN-102). Even this cover is not a patriotic in the normal sense. The patriotic flag is on the envelope flap.

For information on plating the stamp see Calhoun – “References”.

For information on the different Petersburg postmarks used to cancel the provisionals see Postmarks – “References.” All postmarks used in the period of provisional use were struck in blue ink.

Some items in the census include the plate position.

The Calhoun census (see “References”) contains some listings which are not in this census and this census includes some that are not in the Calhoun census.

NOTE: Every effort is made to ensure the accuracy of the census, but the inclusion of an item is not a guarantee of authenticity.

Notes

Postmarks

Most strikes of the Petersburg postmarks are incomplete due to the way they were struck. In some cases, it is not possible to identify the type postmark. All postmarks from the provisional period are in blue ink.

Four types of the Petersburg postmark are recorded on provisionals listed in this census. These types closely follow the classification in Kevin Andersen's article on the Petersburg postmarks (Andersen – “References”).

Type A – Prewar postmark with the integral “3 cts” removed but leaving remnants.

Type B – Postmark with integral “5 cts” which gradually began to break and drop down.

Type C – Postmark with “Va.” at the bottom of the postmark.

Type D – Postmarks which cannot be identified as a specific type.



Type A postmark – note the remnants of “3 cts” vary considerably from a large smudge to almost nothing. Used 1 August 1861 to 29 July 1862.

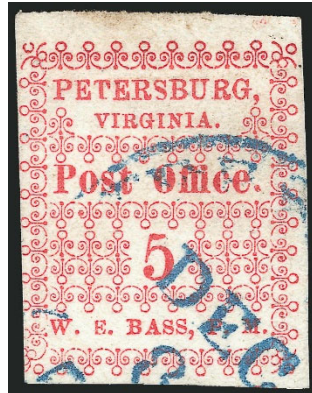


**Type C postmark

Used 10 January 1862 to Mar 1865**

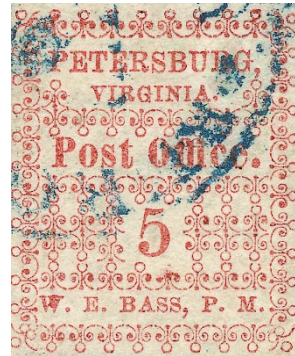

Fakes

There are two fakes of the Petersburg provisional which collectors need to be aware. Both are easily distinguished from the genuine

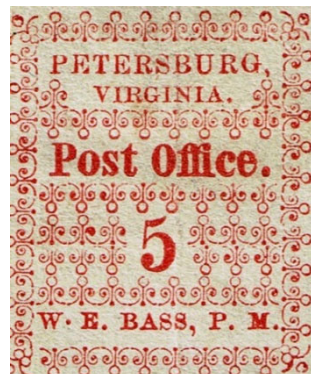


Genuine - Position 2

On the genuine stamp the balls on the ornaments above the postmaster's name are down, except for position 5 where the balls are up. On the genuine "PETERSBURG" is in a larger font than "Virginia" and appears bold. The flags on the "5" are relatively flat on top. Also, the flag of the "5" on the genuine position 2 is shorter than in the other positions.

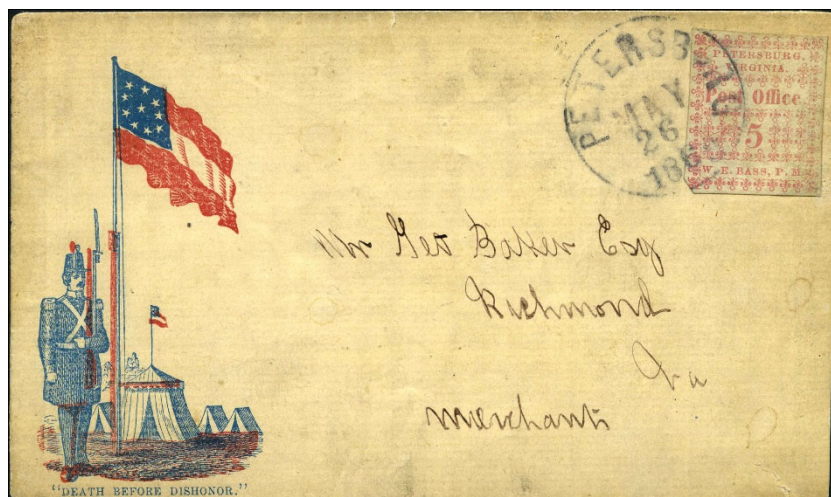


Fake – B

All recorded fakes are of position 5 with the balls on the ornaments above the postmaster's name up. Also, the balls on the ornaments to the lower left of the "5" form a figure "8." This is not true for position 5 or any of the other positions on the genuine stamp.

On Fake A "PETERSBURG" is not in a bold font and the flag of the "5" inclines to the upper right.

On Fake B "PETERSBURG" and "VIRGINIA" are the same size font and the flag of the "5" dips down and ends with an upward flourish.

Fake B is also known in blue.
