## Control Markings on THO-GA-E01

The Thomasville stampless provisionals were prepared by handstamping envelopes with PAID 5 markings. The first (THO-GA-E01) required two strikes: a "PAID" and the "5". In addition, a control was applied on the reverse in the form of a dated postmark (see control markings above). The date of Control B was determined by comparing the tops of "5" and "7" day dates in other postmarks. The top of the "5" has a distinct upward slant to the right.

The second marking (THO-GA-E02) was specially prepared and only required a single strike of the marking. No control marking was used with this marking.

**NOTE:** The inclusion of an item in this census is not a guarantee of authenticity.

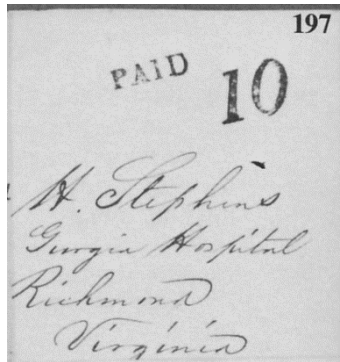

### The 10c Provisional

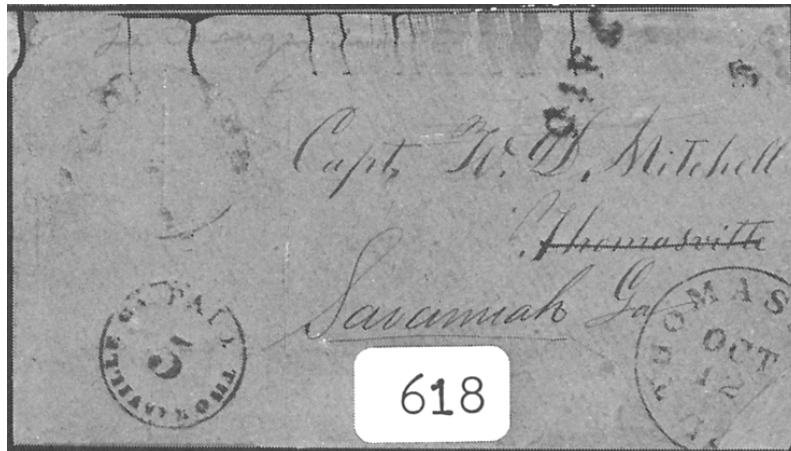
The cover illustrated below is the basis for the CSA Catalog listing of a 10c black Thomasville provisional (THO-GA-E03). Further research on this cover reveals there is no control marking on the reverse of the cover. Consequently, it should be categorized as a 10c stampless cover.

### Provisional Marking Used as a Forwarding Marking

There are at least two examples of the Thomasville Type E02 provisional marking used as a forwarding marking. Both are illustrated below.



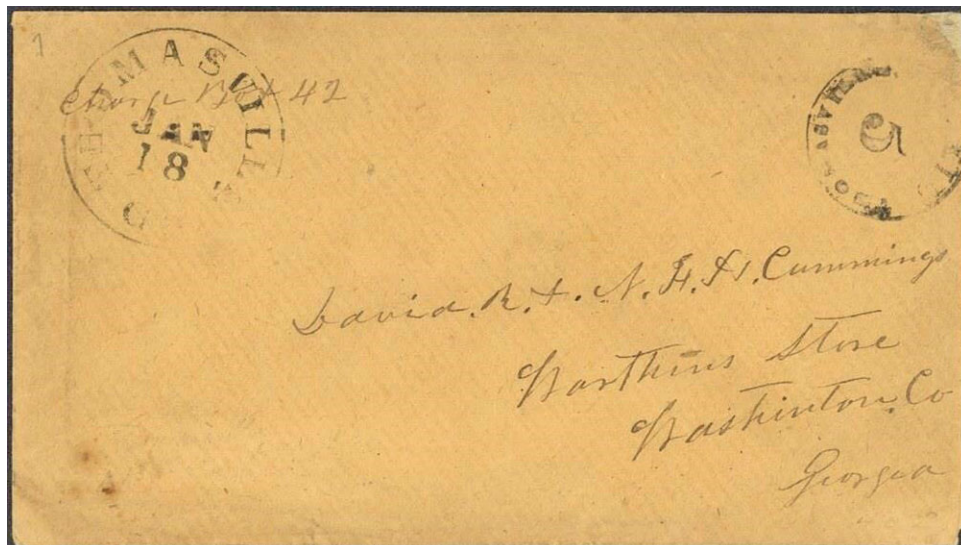
Cover mailed to Thomasville from an unknown town (faint postmark at upper left) with a "5" and "PAID" marking at upper right. On arrival at Thomasville the cover was forwarded to Savannah with the Thomasville Type E02 provisional marking (lower left) and 12 Oct Thomasville postmark (lower right). Cover mailed from Augusta, Georgia on 2 Oct (postmark upper right) and faint “PAID” and “5” marking upper center. On arrival at Thomasville, it was forwarded to Savannah with the Thomasville Type E02 provisional marking and the 5 Oct Thomasville postmark (upper center). Courtesy Daniel F. ### Charge Box Marking

The cover illustrated below has a charge box marking under the postmark. Some consider such markings an indication the postage was paid at the time of mailing and thus not a provisional. This is a controversial subject, and each collector must make his own determination. This cover is included in the census.
