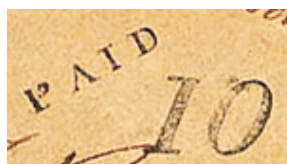

Eufaula Stampless Markings (not to scale)

The different markings are identified by the 2012 *Confederate States of American (CSA) Catalog and Handbook* Stampless Type. The letters "X, Y, and Z," are used to designate added items not in the CSA Catalog.

**Only stampless covers with a handstamped marking are included in the census.**

This census is based on images of covers. Only covers for which an image was obtained are listed in the census. For this reason, this census may be far from complete.

**NOTE:** Every effort is made to ensure the accuracy of the census, but the inclusion of an item is not a guarantee of authenticity.

**5c Use in June 1861:** The last use of a 5c marking in this census is February 1862. Therefore, any 5c use in June is assumed to be 1861.

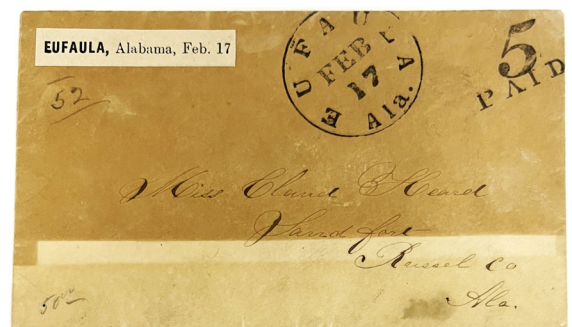
