Monroe Stampless Markings (not to scale)

The different markings are identified by the 2012 *Confederate States of America (CSA) Catalog and Handbook* Stampless Type. The letters "X, Y, and Z," are used to designate added items not in the CSA Catalog.

Only stampless covers with a handstamped marking are included in the census.

This census is based on images of covers. Only covers for which an image was obtained are listed in the census. For this reason, this census may be far from complete.

NOTE: Every effort is made to ensure the accuracy of the census, but the inclusion of an item is not a guarantee of authenticity.

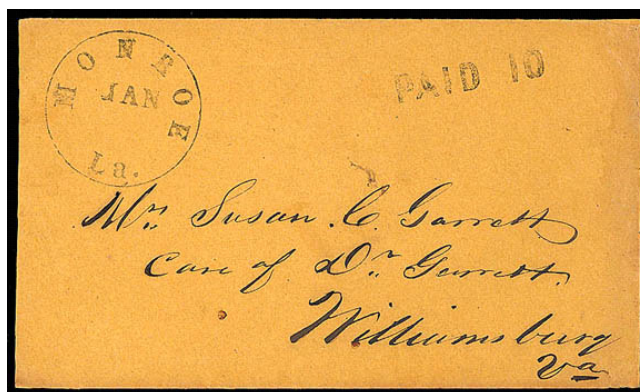
